## HEALTH & SAFETY

All materials used have been designed for professional use, are hypoallergenic and comply with EU Standards. As with any cosmetics, some people may be sensitive to some ingredients. Upon request a small skin test may be issued. We will not be held liable in the event of any reaction.

We will not paint anyone who appears to be suffering from chicken pox, head lice, impetigo, cold sore, conjunctivitis or any other infectious skin complaint. Eczema, open cuts and grazes are not suitable surfaces to paint but a design on a clear area such as hand or arm is perfectly possible.

We will not paint signs, symbols or other designs, which are in any way racially or religiously offensive.

We reserve the right to refuse to paint anyone who is abusive, violent, or intoxicated.

All equipment is cleaned after *each* job. Sponges are washed at 90 degrees and brushes are cleaned with Isopropyl Alcohol removing all bacteria, then cleaned with shampoo.

Towels are brought to every event to protect your table surfaces. We will be as careful as possible when painting, however, we accept no responsibility if face paint/glitter gets transferred onto any surfaces at venues or homes, clothing, carpets, vehicle interiors, bouncy castles, or other soft furnishings.

**COVID19**

I'm fully COVID19 vaccinated (24/3/21 & 3/6/21) but should I feel ill or have any symptoms of COVID19 then I will immediately self-isolate for 2 weeks. This could mean that your appointment is cancelled at short notice, but it is done entirely for your own safety and will be re-scheduled within 12 months. Likewise, if you or any of the people you live with feel ill or display any symptoms of COVID19 – please advise me as soon as possible.

**Upon arrival:**

- I'll be wearing face mask and visor and will wash my hands upon arrival.
- Introduce myself to you (For children's events it would be useful to have someone you know on hand during the working time to help maintain the line or I will lay some Hazard tape on the floor to keep a demarcation for the children)
- Sanitize and set up on your table.

**During working time:**

- **Painting on the face or arm** – This will be an option I'll ask.
- **One sponge per person** - A fresh sponge is used for each person which will not be reused. These sponges will then be put in a separate container to be sterilized away from the event.
- **Brushes are cleaned before AND after painting each person** – I have a large selection of brushes available to keep help timings.
- **Hand sanitizer** – Will be available for everyone to use.
- **Face painting lips** – I'm not painting the lips at this current time.
- **Face painting pots** – Face painting pots will be left closed, just in case someone coughs or sneezes over paints. If someone touches any paints, it will be sprayed with a makeup product sterilizer before being used again. The paint is high quality and manufactured with anti-bacterial ingredients, so has preservatives in it to kill bacteria.

**CANCELLATIONS:** - Should you decide you need to cancel or postpone your event, please just let me know ASAP. Deposits are not returnable, but you can transfer your existing booking towards a party any time within the next 12 months. You will not need to pay another deposit. If your party is cancelled due to another Government Lockdown, your deposit will be refunded.

### REMOVAL

**Face Paints** are removed by washing with soap and warm water. Baby wipes will not be sufficient as many contain alcohol based ingredients which make the paint stain the skin. Some colours may linger (mainly turquoise, green & black) therefore a repeat wash with baby shampoo is recommended.

**Glitter Tattoos** are removed by soaking the area with warm soapy water for 5-10mins, then manipulated with baby oil and exfoliating glove.

**Clothing** that has been in contact with face paint should be soaked in COLD water overnight with washing powder before washing normally. A full list of face paint ingredients is available upon request.
